



Camp Mission Access: Acknowledgement, Waiver and Release

Read Carefully – this document limits your and your child’s legal rights.

I declare that I am at least 18 years of age and that I am the parent or legal guardian of the Participant. In consideration for the Participant being allowed to participate in Camp Mission Access (“Camp”) and Camp activities and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

- A. I, for myself and on behalf of the Participant, agree, understand and acknowledge that:
1. the Participant’s participation in the Camp and Camp activities is voluntary;
 2. there are potential risks to property and to Participant health and safety involved and associated with Camp and Camp activities and the administration of prescribed medications (“Drugs”), if any, to the Participant by the Camp and its organizers, employees and volunteers (collectively called the “Camp Helpers”);
 3. the Participant must obey all Camp rules as determined by the Camp Helpers;
 4. if the Participant disobeys the Camp rules or if he or she is endangering him or herself, other participants, staff or volunteers, as determined by Alison Neuman, acting reasonably, the Participant will not be permitted to participate in Camp and Camp activities, and I will be contacted. In such cases, I agree to pick the Participant up promptly; and
 5. no refund, rebate or any other compensation will be issued to me or to anyone if the Participant is required to leave Camp in accordance with paragraph 4 immediately above; and

B. I, for myself and on behalf of the Participant, forever release, remise, discharge and save harmless Camp Mission Access, Alison Neuman, Kaylee Borg, Katherine Restoueix, Sandy Tree Communications, Boyle Street Community League, Fireside Publications, Dream Write Publications, Ice Rose, Don’t Eat Family, Squeakers and Sneakers, Agents in Training, E4C, Camp organizers and Camp sponsors (called, collectively, the “Camp Organizations”) and any and all organizers, officers, directors, shareholders, agents, contractors, volunteers, employees, and associates of each of the Camp Organizations (collectively, together with the Camp Organizations, called the “Camp Organizers”), from and against all and any claims, actions, causes or action, suits, costs, debts, duties, accounts, bonds, covenants, contracts, expenses, demands, damages, losses and expenses in respect of any injury to the Participant, including death, or any theft or loss of, or damage to, any property of the Participant or of my property and any other property of any nature whatsoever and howsoever caused, resulting from, arising out of, in connection with or with respect to the Participant’s participation in Camp and Camp activities, or the administration or lack of administration of Drugs to the Participant by the Camp Helpers, notwithstanding that such injury, including death, or such theft, loss or damage may have been contributed to or occasioned by any act or failure to act (including without limitation, negligence and gross negligence) of one or more of the Camp Organizers; and

C. I specifically agree to assume full liability and responsibility for any and all claims, actions, causes or action, suits, costs, debts, duties, accounts, bonds, covenants, contracts, expenses demands, damages, losses and expenses with respect to any damage to any property and any injury, including death, to any Camp participant, including the Participant, howsoever caused, whether directly or indirectly, by the Participant; and

D. I, for myself and on behalf of the Participant, agree that this Acknowledgement, Waiver and Release will enure to the benefit of the Camp Organizers and their respective heirs, executors, representatives (whether personal or legal), administrators, successors and assigns, and it shall bind my heirs, executors, administrators, representatives (whether personal or legal), successors and assigns.

I have read and understood this Acknowledgement, Waiver and Release and I am informed of the Camp activities and risks and I consent to the Participant attending and participating in Camp and all Camp activities.
